Item 1 Response to CO77-2011 - Changes to Licensing By-Law 395-2004

Melanie Coulter, Executive Director, Windsor Humane Society appears before the committee, suggesting that additional changes to By-law 395-2004 could reduce the number of animals bred in inhumane conditions in puppy mills and backyard breeding operations and concludes by stating that the Humane Society would be willing to work with Administration.

Salient points of discussion relating to Licensing By-law 395-2004, are as follows:

- In March 2008 several amendments were made to By-law 395-2004 to further facilitate the well-being of animals and to protect the public.
- Prior to the issuance of a licence an inspection of the pet shop is conducted.
- Pet shops must keep a detailed record of each dog and cat purchased or otherwise obtained.
- By-law Enforcement staff review the register as part of their annual inspection prior to licenses being renewed.




