## 7. ADMINISTRATOR'S REPORT

A. Sirbu advises in February, 2016 the MOHLTC and the Erie St. Clair LHIN advised the Case Mix Index (CMI) allocation for the 2016-17 funding year will decrease and, the Nursing and Personal Care per diem will increase only slightly. Huron Lodge expects a budget shortfall in the subsidy category of approximately \$84,000 at December 31, 2016.

In response to a question asked by Councillor Gignac regarding issues such as post traumatic stress disorder, A. Sirbu responds the LHIN has received special funding for behavioral disorders.

That the report of the Administrator of Huron Lodge dated May 26, 2016 entitled "Huron Lodge Long Term Care Home - Administrator's Report to the Committee of Management" regarding an update on issues relating to resident care, the Ministry of Health and Long Term Care, the Local Health Integration Network and other initiatives that impact the Long Term Care sector **BE RECEIVED** for information and **BE APPROVED** for the period March 1, 2016 to May 30, 2016.
