5. Business Items

5.1 Environmental Master Plan Update

The City of Windsor Environmental Master Plan (EMP) 2017 is **attached** as Appendix "A".

K. Richters provides an overview of the EMP as follows:

- The original EMP was approved by Windsor City Council on July 24, 2006 and is meant to be updated every 10 years.
- New to the EMP is consideration of climate change, invasive species, local food and other relevant issues.
- The EMP is implemented alongside the Climate Change Adaptation Plan and the Community Energy Plan.
- The Plan does not stand on a pier of environmental performance alone, but also incorporates economic and social aspects which are crucial to the overall health and quality of life of Windsorites.
- The EMP will proceed to the Environment, Transportation & Public Safety Standing Committee and will be tabled for 30 days to allow for public comment.

D. Coronado suggests targets and timelines be added to the EMP document and notes the public comment period of 30 days is short.

Moved by D. Coronado, seconded by D. Grant,

That the public comment period for the City of Windsor Environmental Master Plan 2017 of thirty (30) days **BE INCREASED**.

5.2 Potential Film Screening

K. Richters suggests as there is no Green Speaker scheduled to speak in the Fall, that consideration be given to the showing of the film "Before the Flood". This film presented by National Geographic, features Leonardo DiCaprio on a journey as a United Nations Messenger of Peace, traveling to five continents and the Arctic to

witness climate change firsthand. She adds preliminary costs for weeknight rentals are approximately \$1,500 for SilverCity or, \$700 for Lakeshore Cinema.

It is noted Michael Schneider, guest has requested to provide a presentation as a Green Speaker. The topic of his speech would be energy efficiency in the residential home market.

That **APPROVAL BE GIVEN** to an expenditure in the amount of \$5,228.99 for costs associated with the following initiatives:
