#### 12. ADJOURNMENT

#### Recommendation regarding a Provincial Urban Tree Policy:

WHEREAS urban forests have been shown to produce energy cost savings, for example, residents of Peel Region's urban areas save \$2.5 million annually in heating and cooling through shading and windbreak provided by trees<sup>1</sup>;

WHEREAS urban forests have the potential to improve air quality through the removal of air pollutants and the storage and sequestration of carbon. For example, recent studies show that Peel Region's urban forest removes 855 tonnes of air pollution annually, sequesters 19,000 tonnes of carbon annually and stores 400,000 tonnes in total. These services are valued at \$9.1 million, \$550,000 and \$11.5 million respectively<sup>1</sup>;

WHEREAS methods of green infrastructure such as urban forests have been show as a cost-effective means to decrease stormwater runoff and combined sewer overflows by capturing runoff and retaining it before it can reach the sewer system<sup>2</sup>;

WHEREAS an investment in green infrastructure is an investment in biodiversity, a declared priority of both the provincial and national governments;

WHEREAS numerous studies indicate that property values increase anywhere from 5 to 30 percent depending on the size and type of green space, the type of housing and the distance from the green space<sup>3</sup>;

AND WHEREAS urban forest issues can result in high unforeseen costs for municipalities, for example, the City of Windsor spent \$4 million as a result of the Emerald Ash bore pest issue in Windsor;

BE IT RESOLVED THAT City and County Councils urge both the Provincial and the Federal governments to develop and implement Urban Tree Policies which provide municipalities with direction as well as monetary support when dealing with urban tree issues.

#### ONGOING INITIATIVES

#### 1. Provincially Significant Wetlands Subcommittee

The subcommittee is prepared to speak as a delegate to City Council when the airport woodlots and open space designation report is brought forward.

#### 2. Renewable Energy Media Campaign with Generator Design

For the second phase of our education campaign, we would like to focus on energy conservation. This campaign will highlight the benefits of conserving energy, such as reducing air pollution and greenhouse gas emissions. This topic will create the potential to have many campaign partners, including educational institutions, local distribution companies such as EnWin, as well as businesses who sell energy conserving products to homeowners. We are in the process of introducing our campaign to potential partners and hope to set up meetings with interested organizations in November.

#### 3. Water Quality Subcommittee

The subcommittee hosted a successful press conference to unveil our PSA video produced to highlight the causes and potential solutions to algae issues in Lake Erie. The event was well attended by members of the public, Councillors, media, as well as ERCA, MOE and IJC representatives.

The video is currently on YouTube and has been watched by over 250 residents. Copies of the video have been distributed to Cogeco as well as some schools. This education initiative will continue to be ongoing.

In addition, the subcommittee organized a Green Speaker Series event on October 21<sup>st</sup> in Kingsville. Speakers included Jim McKenzie, Principal to the Federal Commissioner of Environment and Sustainable Development, and Chitra Gowda, Water Quality Specialist with ERCA. Media presence at the event included AM 800, CBC, and the Harrow and Kingsville newspapers.

#### 4. Provincial Environmental Advisory Committee Symposium

WHEREAS the ridership in Windsor has increased by 4% this year;

WHEREAS numerous developments downtown support an increase in service from outlying areas to the downtown, including the new aquatic centre and University of Windsor campuses as well as the St. Clair College campuses;

WHEREAS a decrease in service will result in decreased ridership and will have lasting effects on residents' consideration to take transit;

WHEREAS implementing an increase in user fees can deter transit ridership;

BE IT RESOLVED THAT City Council exempt Transit Windsor from the 10% budget cut proposal allowing Transit Windsor to maintain their 2012 budget and further, allow Transit Windsor's budget to increase in order to provide increased preventative maintenance and transit service to Windsor residents.

## Video campaign aims to reduce lake algae

### Homeowners urged to do their part

A new video onYouTube is encouraging local residents to do their part to reduce bluegreen algae in our lakes by maintaining septic systems, mulching grass to avoid using lawn fertilizer and using rain barrels and phosphate-free detergents.

The educational video is more than five minutes long and is called Overload: Lake Erie Blue Green Algae. It was done by the Windsor-Essex County Environment Committee in partnership with the Essex Region Conservation Authority and the International Joint Commission. ERCA also has fact sheets on its website that answer common questions on blue-green algae and phosphorus.

Jim McKenzie, a principal with the federal commissioner of the environment and sustainable development, will be talking about blue-green algae Oct. 21 in Kingsville.

The Windsor Essex County Environment Committee is holding the free speaker series at the Kingsville Arena with light refreshments at 12: 30 p.m. and speeches at 1 p.m. Chitra Gowda, water quality specialist with the Essex Region Conservation Authority, is also expected to speak.

The video includes a satellite image that shows the blooms, which were the worst in decades in Lake Erie in 2011.

"If everyone did one thing that would result in some pretty significant change," ERCA general manager Richard Wyma said Monday.

"There's a lot of little things people can do," he said. "Finding phosphate-free detergents and making sure septic systems are maintained regularly and ... if you have shoreline properties trying to naturalize shoreline properties to reduce erosion."

Nutrients including phosphorus help algae grow. Phosphorus can come from sewage, septic tanks that aren't working properly, waste management systems and fertilizer.

The video talks of trying to keep water on the land as long as possible and reducing agricultural run-off into streams and lakes.

"We, as communities, need to be more aware of our actions and ultimately we need to make sure that less nutrients go into our lakes and rivers," Wyma said in the video of the algae he described as looking like pea soup.

The video explains possible health impacts such as severe damage to your liver and nervous system if you drink the water or eat fish with high levels of toxins in it. Swimming in the water can cause skin and eye irritations.

The International Joint Commission is studying blue-green algae and its impacts, including the economic impact of the blooms, such as reduced tourism and increased water treatment.

An IJC report with recommendations for U.S. and Canadian governments is expected by October 2013.
