The Chair calls the meeting to order at 2:01 o'clock p.m. and the Committee considers the Agenda being Schedule "A" *attached* hereto, matters which are dealt with as follows:

J. MINUTES

Moved by K. Iacovone, seconded by S. Friesen,

4. **PRESENTATIONS**

-t2 Proposal for Funding from the Capital Project

Sherri Arsenault, Acting Manager of Court Services distributes a quote rrom Access Doors 'N' More in the amount of \$23,848.65 and also distributes various photographs of the doors/washrooms in the Provincial Court, *attached* as Appendix"/\".

S. Arsenault provides the following as it relates to a request for funding from the Capital Account for accessible amenities/retrofits in the Provincial Court - Fine Payments, Westcourt Building:

- Recalls a recent scenario whereby a person in a wheelchair could not open the door leading into the Provincial Offences area and had to beep a horn from the hallway.
- Doors to access the Court are heavy, open inward and are quite narrow.
- If a person is unable to enter the Court, (due to inaccessible doors) they could be convicted of non-appearance.

G. Jones asks who is responsible for the renovation and retrofit? If the space is utilized by the City of Windsor, is the City responsible for the retrofit, or, are the renovations the responsibility of the landlord?

T. Graziano indicates any improvements to the space lies with the tenant (City of Windsor). He notes if the City vacates the premises; the benefit of the improvements will be lost. T. Pearce reiterates the City is responsible for repairs and maintenance to the premises.

G. Jones states it would be prudent to make any decisions relating to the retrofit contingent upon approval by the Legal Department (that such retrofit would be the responsibility of the City) and written agreement by the landlord.

Councillor Sleiman questions if any discussions have been held with the landlord relating to cost sharing this initiative.

Moved by K. Iacovone, seconded by Councillor Sleiman

That the request for accessible amenities/retrofit for the Provincial Court - Fine Payments, Westcourt Building, 99 Chatham Street East in the amount of \$24,000 from the Capital Project 7035138 (Accessibility) Fund **BE APPROVED IN PRINCIPLE** subject to the following conditions:

• Approval by the Office of the City Solicitor

- Written agret:ment and approval by 837690 Ontario Ltd. o/a Westcourt Place
- Discussion with 837690 Ontario Ltd. to determine cost-sharing options Carried.

_,I Proposal for Funding from the Capital Project

John Wolle, Senior Manager of Trartic Operations, Parking & Transportation Planning is present to request funding for the purchase of two Audible Pedestrian Signals (J\PS) to assist the visually impaired in knowing when they are able to cross the street at signalized intersections. I le notes the two locations for the \land PS arc Wyandotte Street East/Raymo and Wyandotte Street East/Pillette. He indicates currently there are six audible traffic signals in the city.

J. Wolfe states in 2016, under the AODA, when over 50% of pedestrian signals are to be replaced at signalized intersections, installation of APS will become mandatory.

S. Boghean reports there are different styles of APS which include sounds like beeping, chirping, and cuckooing. She indicates the APS located at Wyandotte and California is too loud and can be distracting. She further noted it can be confusing for persons who are blind if the signals are too loud and they can hear the audible traffic signals when they are at another intersection.

P. Best states the location and height of the button on the APS is extremely important. He notes vibration of the mechanism assists the visually impaired to locate the button. He adds the public should be apprised of the APS.

J. Wolfe suggests the utilization of a "chirp" in one direction and a "cuckoo" in the opposite direction. He states the APS is fully recordable and any sounds can be made which includes a voice that says "cross Wyandotte Street now". He notes that holding the button and signal together activates the sound (in approximately 5-6 seconds). He noted they would be open to suggestions from the Committee regarding the most appropriate sounds.

P. Best states there is a need for a standard sound for those travelling in a north/south and east/west direction.

Moved by P. Best, seconded by J. Azlen,

That **APPROVAL BE GIVEN** to an expenditure in the amount of \$19,000 (excluding taxes and freight) from the Capital Project 7035138 Accessibility (Fund) for the purchase of two (2) Audible Pedestrian Signals to be located at the Wyandotte Street East/Raymo intersections and the Wyandotte Street East/Pillette Road intersections.

Carried.

5 **BUSINESS ITEMS**

5.1 Canada Post <u>Community Mailbox Implementation</u> in Windsor

The salient points or discussion as it relates to the Canada Post Community Mailbox implementation in the City or Windsor arc as follows:

- Door to door mail delivery will be phased out over a five year period.
- l\;rsons with disabilities can request an accommodation. i.e. door to door delivery once a week, however. a doctor's note will be required for this service.
- Canada Post determines the locations of the community mailboxes but the City is reviewing and commenting on the suggested locations.
- WAAC to submit comments to Administration regarding this initiative.
- Suggestion to also include persons with disabilities other than just mobility disabilities to receive accommodations such as the once a week mail delivery. (ie: visually impaired, developmental disabilities, and those with mental illnesses who would have difficulty with such a task)

K. Iacovone provides a "dralt" letter written on behalf of the Multiple Sclerosis Society outlining concerns relating to the community mailboxes, *attached* as Appendix "B". Some of the concerns include adequate lighting, panic button with direct link to emergency services, snow and ice removal and ensure individuals can access their mail if using a mobility device.

Moved by K. Iacovone, seconded by B. Lefort,

That a Subcommittee **BE ESTABLISHED** to review and provide comments relating to the Canada Post Community Mailbox implementation in the City of Windsor.

Carried.

5.2 Accessible Taxi Cabs

G. Jones suggests the Supervisor of Licensing be invited to attend a future meeting of WAAC to provide an update relating to accessible taxi cabs.



RE: Termination of Home Mail Delivery- Impact on those with disabilities.

Dear

I am writing this letter on behalf of the Multiple Sclerosis Society, Windsor-Essex County Chapter. Currently we have a client base of 250, and an additional 75 active members. MS is a neurological

canada has the highest rate of multiple sclerosis in the word. It is the main cause of adult disability w!th the exception of automobile accidents in this country.

We realize that a decision to end home delivery is already finalized and about to be rolled out. Our hope is that the needs of those **with** disabilities be considered **with** both thought and sensitivity. In that process, proper care has been taken in developing a pian that is sensitive to those needs.

Our key concerns:

- 1. Proper curb cuts are in place.
- 2. Adequate lighting is installed.
- 3. Accessibility of the boxes are lowered for those using a mobility device.
- 4. Boxes be marked in braille for those that are visually impaired.
- 5. That boxes be located in areas that are visible and do not leave our most vulnerable population at risk of harm due to isolated location.
- 6. Panic button with direct link to emergency services.
- 7. That there will be adequate space surrounding the boxes, on paved surfaces .
- 8. That testing take place with persons using different size and type of mobility devices.
- 9. That a plan be in place for delivering the mail to those unable to get to their box.
- 10. A superior plan be in place for snow and ice removal around the boxes, and access to boxes be maintained in a superior manner.

We hope that canada Post will be diligent in undertaking this plan. It is a worry for many. Please picture yourself or one of your family members in a circumstance of vulnerability due to a disability. Spend a few hours in a wheelchair, using a walker, or simulate a loss of vision and realize what this loss of service means to these people. All of us expect Canada Post to be by the side of all Canadians.
