7. **APPLICATIONS/HEARINGS**

(a) **Mary Ferrar** **Fantasy Playhouse** **Body Rub Parlour**

No one is present to speak to the matter.

In response to a question asked by Councillor Gignac regarding if the body rub parlour
is operating, C. Robertson responds the business is intermittent.

Moved by Councillor Gignac, seconded by J. Fathers,
WLC13/14 That the application for a Body Rub Parlour - Owner licence at 555 Pelissier
Street, Windsor, Ontario submitted by Mary Ferraro/a Playhouse Massage+ **BE REFUSED.**

(b) **2427716 Ontario Ltd. o/a Royal Limousines of Essex County** **Livery Vehicle**
{Class "C" - Executive}

No one is present to speak to the matter.

C. Robertson states there are currently seven Class "C" Livery Vehicles licensed in the
City of Windsor. He notes if the licence is approved, the decision made would be in compliance
with the regulations pertaining to Class "C" Livery plates allowed, being fifteen. An inspection
of the proposed livery vehicle was conducted by By-law Enforcement and the vehicle was
determined to be in "excellent" condition.

Councillor Gignac requests the applicant be made aware that the vehicle must be replaced within twelve years.

(c) **1830062 Ontario Inc. o/a RJ Wrigley's Sports Lounge and Grill - Hospitality Food Service - Liquor Service Ancillary**

No one is present to speak to the matter.

In response to a question asked by Councillor Gignac regarding if the business is operating, C. Robertson responds affirmatively.

It is noted on August 12, 2014, the Fire Prevention Officer attended the premises at 1521 Riverside Drive West and determined the business was non-compliant. Fire Prevention Officer Mike Costs indicated - *"No fire safety plan. Hoods need to be cleaned. Fire suppression system needs to be tested. No records on site. Alarms need to be done. Pull alarm signage needs to be put above all pull alarms"*. On September 16, 2014, the Fire Prevention Officer re-attends the premises and reports that the deficiencies in the initial inspection were not corrected.

Moved by Councillor Gignac, seconded by J. Fathers,
WLCIS/14 That the application for a Hospitality Food Service - Liquor Service Ancillary licence submitted by 183062 Ontario Inc. o/a RJ Wrigley's Sports Lounge and Grill at 1521 Riverside Drive West **BE REFUSED**.

(d) **Windsor Croatian Centre Limited - Public Hall & Hospitality Food Service - Liquor Service Ancillary**

Matthew Pavelich, Secretary and Monica Babic, Manager, Windsor Croatian Centre are present and available to answer questions. Monica Babic requests a one month extension of time to complete the Fire Plan (she alleges was never required in the past) and to correct the deficiencies. She notes the Centre is operating at a loss, hence there are financial implications.

C. Robertson advises Fire & Rescue Services cited numerous violations and as of October 21, 2014, none of the deficiencies were corrected.

Councillor Gignac states a Public Hall Licence has been issued since 1997 and asks if there have been issues prior to this matter. C. Robertson reports there were no outstanding deficiencies in the past that would warrant the refusal of the licence.

In response to a question asked by Councillor Gignac regarding the cost of a Fire Plan, M. Coste responds the Plan ranges from \$400 to \$1,500 and notes it takes approximately one month to complete.

V. Critchley indicates initially the Windsor Croatian Centre held a Public Hall Licence and issues arose when an application was made for a Hospitality Food Service and Liquor Service Ancillary Licence.

J. Fathers questions the "DO NOT OCCUPY" directive by Windsor Fire & Rescue Services noted in deficiency #11 as follows: "*structural issue at roof of storage room west of west hall (southend of 5243 Tecumseh Road East) - DO NOT OCCUPY until repaired - OTR being issued to address 5243*". R. Vani responds the area in question is a mezzanine area and notes by storing material on top the roof, there is a potential for collapse.

Moved by Councillor Dilkens, seconded by Councillor Gignac,
WLC16/14 That an extension of time to November 22, 2014 **BE GRANTED** to allow for the applicant Matthew Pavelich, Windsor Croatian Centre Limited, 5659 Tecumseh Road East, Windsor, Ontario to operate the Public Hall and to correct the deficiencies as outlined by Windsor Fire & Rescue Services, including the creation of a Fire Plan and failing that, that the following recommendation **BE UPHELD:**

*That the Windsor Licensing Commission **REFUSE TO RENEW** the Public Hall licence and that the application for Hospitality Food Service - Liquor Service Ancillary submitted by Windsor Croatian Centre Limited **BE REFUSED.***

Carried.

(e) **Happy Days Diner-Hospitality Food Service**

No one is present to speak to the matter.

C. Robertson states it is not in the public interest to issue a licence as there are outstanding issues with Windsor Fire & Rescue Services. He advises the business is currently operating.

Moved by Councillor Gignac, seconded by J. Fathers,
WLC17/14 That the Windsor Licensing Commission **REFUSE TO RENEW** a Hospitality Food Service licence to Alex Jabbour o/a Happy Days Diner located at 2421 Walker Road.
