C. Robertson advises Administration has requested the withdrawal of Item 7 (a) Serbian Centre Ltd, 6770 Tecumseh Road East - Hospitality Food/Liquor Service Licence as the applicant has complied with the outstanding deficiencies identified by the Public Works Department.

That the matter 7 (a) relating to a Hospitality Food/Liquor Service licence to Serbian Centre Ltd. located at 6770 Tecumseh Road East, Windsor Ontario **BE WITHDRAWN** as the deficiencies identified by the Public Works Department have been corrected.

**6. Licence Transfers**

**(a) Transfer of Taxicab Plate #208**

The Transferor and the Transferee are not present to speak to this matter.

Moved by Councillor Kaschak, seconded by Councillor Costante,

That the transfer of Taxicab Plate #208 from Mr. Khuram Shahzad to Mr. Ibrahim Nabhan Ishaobi **BE APPROVED** with the following conditions:

- i. Mr. Ishaobi be given thirty (30) days from the date of this decision to submit a vehicle for inspection that complies with Schedule 5 to By-law 137-2007, including a valid safety standards certificate.
- ii. Mr. Ishaobi must submit a Plate Holder application and pay the applicable fee.
- iii. Mr. Ishaobi shall provide verification that full compensation has been made to Mr. Shahzad in consideration of the transfer of taxicab plate #208.
- iv. Mr. Ishaobi shall not lease the plate for a one year period as stated in Schedule 5, Section 21.3 of Licensing By-law 137-2007.

### (b) Precision Care & Auto Wash Ltd. – Automobile Service Station – Car Wash

Anthony Pipolo, representative on behalf of Ben Scurto is present to speak to this matter.

C. Robertson states Administration suggests an amendment to the recommendation outlined in the report to grant an extension of one week to allow for Pollution Control to visit the site to ensure the deficiencies have been corrected. He adds any future non-compliance will result in immediate suspension until the next meeting of the Windsor Licensing Commission.

Anthony Pipolo advises Hurricane Hydrovac attended the site this morning and the issues have been resolved. He ensures compliance will be maintained and regular cleaning of the interceptor will be undertaken.

Moved by Councillor Costante, seconded by Councillor Kaschak, WLC5/2019 That an extension of time of seven (7) days **BE GRANTED** to Mr. Ben Scurto, Precision Care & Auto Wash Ltd. located at 1451 Lauzon Road – Automobile Service Station – Car Wash to allow for sufficient time for Pollution Control to inspect and ensure all deficiencies have been corrected, and if the matter is *not resolved*, administration will refuse to issue an Automobile Service Station – Car Wash licence, and further, if compliance has been achieved, that administration will issue the licence with the following condition:

*Future pollution control occurrences of non-compliance will result in an automatic suspension of the licence until the next Windsor Licensing Commission meeting.*
