



**1. CALL TO ORDER**

Councillor Halberstadt, Co-Chair calls the meeting to order at 5:33 o'clock p.m. and the Committee considers the Agenda being Schedule "A" **attached** hereto, matters which are dealt with as follows:

The Co-Chair advises that Andrew Pula has submitted his resignation from WECEC.

That Administration **BE REQUESTED** to review the applications previously submitted to determine a replacement for the county citizen seat on the Windsor-Essex County Environment Committee.

4. **MINUTES**

5. **PRESENTATION**

Don Sadler, Executive Director Parks and Facilities is present to provide "green building" initiatives for the Family Aquatic and Library Complex.

Mr. Sadler provides the following as it relates to the "green building" initiatives for the new Family Aquatic and Library Complex:

- City Council has requested the Complex not be a LEED building, however various aspects of LEED will be built into the building design.
- Owner's Statement of Requirements (OSR) provides for minimum standards for the design build.
- Scoring matrix – Proponents will receive more points for their design if the building is sustainable.
- Request for Proposal – Pricing for District Energy or stand alone system. If District Energy is utilized, it will reduce environment impact.
- Ministry of Health pool regulations legislates that water has to be "dumped" daily. "Dumped" water will go to a cistern located in the basement of the Complex and will be re-used to flush toilets and urinals.
- Chlorine is the disinfectant of choice for the 2.2 million gallons of water.

- Mr. Sadler along with the successful bidder (or a representative) requests to come back to WECEC in 2012 to provide an update.
- Solar panels may be introduced dependent upon the design of the roof.

The Co-Chair thanks Mr. Sadler for his presentation and notes he will be invited back in 2012 to provide an update of "green building" initiatives.

## **6. BUSINESS ARISING FROM THE MINUTES**

### **6.1 Enviro Expo**

The following "prizes" are suggested for the Enviro Expo:

- Purchase of one or two bicycles (\$199-\$279 each)
- Environmental cleaning products
- LED lights
- Low energy light bulbs
- Several small prizes rather than a 'grand' prize
- Nightlights with the WECEC logo

### **6.2 Regional Integrated Community Sustainability Plan**

A. Parent advises that application for a Trillium Grant in partnership with ERCA is not doable, as ERCA has made application as the principal applicant.

A. Parent states that the Federation of Canadian Municipalities Green Municipal Fund (GMF) is still a viable option for a Regional Sustainability Strategy.. She notes the GMF provides 50% of the funding; the City of Windsor and the County of Essex must agree to contribute the remaining 50%.

M. Child suggests contacting regional municipal planners to obtain their input relating to the Community Sustainability Plan and report back.

### **6.3 Speaker Series – Elizabeth May, Leader, Green Party of Canada**

A. Parent indicates that contact has been established with the office of Elizabeth May and preferred dates are to be finalized.

Suggestions are made to investigate speaker fees for Richard Daley (former Mayor of Chicago), David Ulrich, Professor of Business, Ross School of Business, or Olivia Chow, Member of Parliament.

**6.4 Financial Summary and Proposed 2012 Budget**

**6.5 WECEC Alternate Appointments**

A. Parent advises that City Council appoints the members to WECEC. If alternates are needed, the organization is required to send a letter (nominating an individual as an alternate) to Council Services.

P. Roberts states that the Ministry of Natural Resources has determined that the wetland delineation has been reduced from 8.9 hectares to 5.0 hectares.

APPENDIX "A"

Dear Sir

The Windsor and Essex County Environment Committee (WECEC) is a formal committee of both City and County Councils. The committee has been following the parkway concepts and developments from its earliest inception. Principally the concerns of the committee are not with the parkway project as a whole or with the execution of the detailed ESA permits. The concerns relate more directly to the compensation of wetlands not previously identified in the compensation strategies and the means to create a forum for our committee and the environmental community to express and outline opportunities to incorporating meaningful ecological linkage and compensation concepts within the project footprint and immediate vicinity.

Wetlands protection, particularly those which have been designated as provincially significant and opportunities to create ecological linkage and wildlife corridors rank among the highest of priorities for our local environmental community which is also reflect in the Provincial Policy Statement. WECEC has made recommendations to City and County Council's in the past to prioritize these opportunities.

The committee is specifically interested in what your understanding is, as the constructor of the parkway, 1) of how much of the prescribed compensation land area required from the ESA's has been secured and what is the schedule for works for the compensation areas, 2) what is the role of the WEMG with design-build plans to deal with the compensation of loss of 5.0 Ha of Provincially Significant Wetlands as now outlined by the OMNR , 3) and what forum can be created for a review of concepts previously identified at stakeholder meetings to discuss habitat and wetland compensation and linkage strategies.

The objective of this letter is to organize a presentation from the WEMG to the WECEC and ultimately share concepts this committee and its partners have for good ecological design for some of the issues we believe may still be outstanding.
