

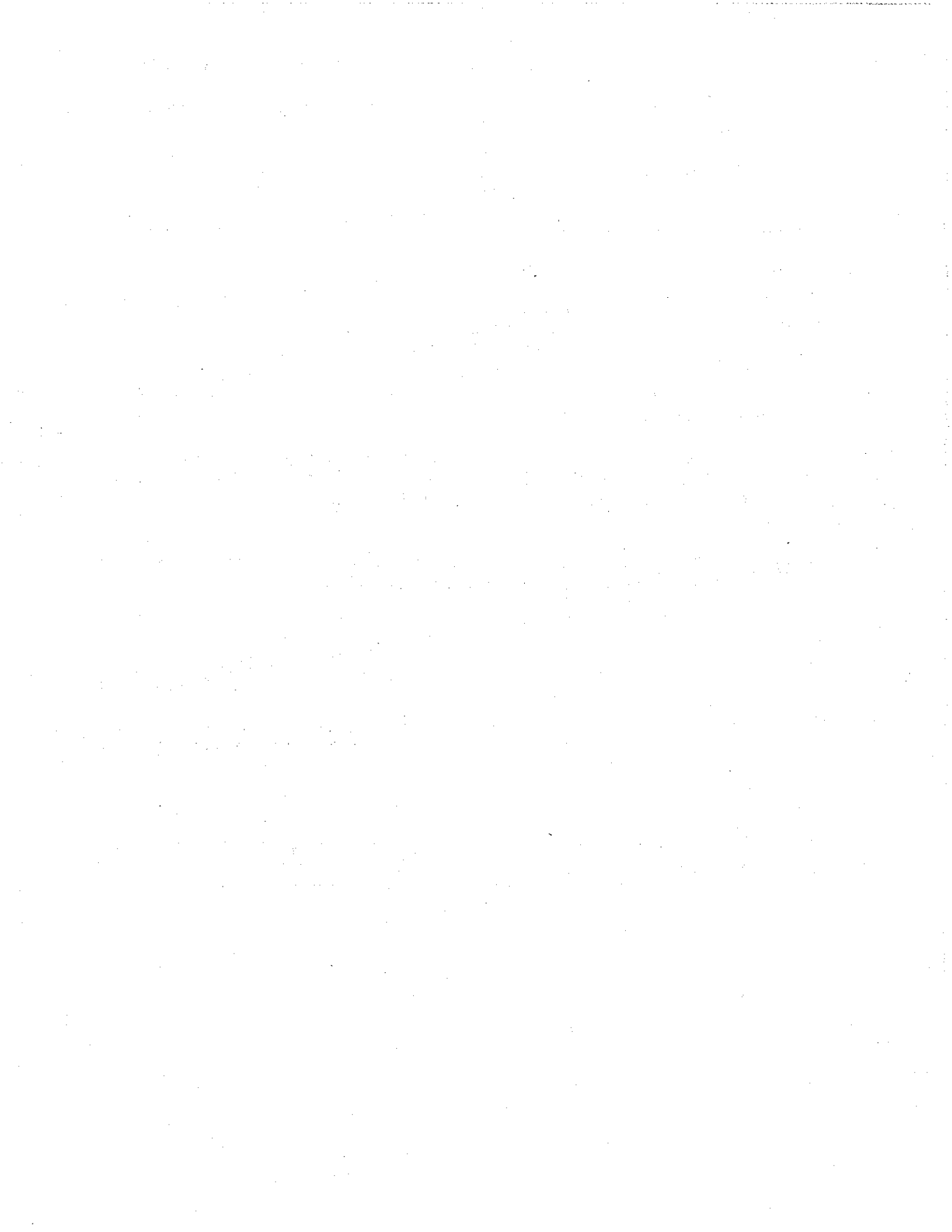

**1. CALL TO ORDER**

Charlie Wright, Co-Chair calls the meeting to order at 5:36 o'clock p.m. and the Committee considers the Agenda being Schedule "A" **attached** hereto, matters which are dealt with as follows:

5. PRESENTATION

Draft Climate Change Adaptation Plan

Karina Richters, Environmental Coordinator is present to provide information relating to the Draft Climate Change Adaptation Plan. The "Draft" Plan is attached as Appendix "A". The PowerPoint presentation entitled "Corporate Climate Change Adaptation Initiative" is distributed and attached as Appendix "B".

In response to the question – "Why is Adaptation Required?" the following remarks are noted:

*"Regardless of the cause, changes in weather patterns already pose risks to the property, and the natural world in Ontario that cannot be ignored. Reducing those immediate risks is the only prudent course of action for all levels of government, as well as communities, corporations, businesses, and individual citizens." – Climate Ready Ontario*

*"And now our world is different. The climate has been permanently altered and is on an escalating vector of change, not because of what we are going to put into the atmosphere in the future but as a consequence of what we have already done."- Environmental Commissioner of Ontario, 2009/2010 Annual Report.*

K. Richters indicates the Urban Heat Island Study has been completed. She notes the "hot spots" in Windsor are being reviewed.

K. Richters advises a pilot project for parking lots will be proposed to gain a better understanding of how porous pavements might work on clay soils.

P. Roberts suggests rather than eliminate parks due to the high maintenance costs, follow the example of Memorial Park and naturalize the parks.

Moved by P. Roberts, seconded by M. Bartlett,

That a working group consisting of D. Coronado, M. Bartlett, J. Miller, P. Roberts and R. Tamr **BE ESTABLISHED** to review the possible naturalization and/or repurposing of surplus parks as part of the evaluation process.

Carried.

Moved by M. Child, seconded by D. Coronado,

That Administration as a high priority **BE REQUESTED** to implement low impact development policies and pilot projects such as green/cool roofs, porous pavement and rain gardens, as well as modifications to development standards as outlined in the Draft Climate Change Adaptation Plan.

Carried.

The Co-Chair thanks K. Richters for her presentation.

**Blue-Green Algae in the Great Lakes Presentation**

Chitra Gowda, ERCA, Water Quality Specialist and Paul Santos (cinematographer/editor) are present and available to answer questions. The video identifying blue-green algae in the Great Lakes is provided for WECEC. B. Wansbrough suggests the satellite image of the blue-green algae present in the video be shown at the end to provide additional impact.

The ERCA Blue-Green Algae Blooms Frequently Asked Question (FAQ) is attached as Appendix "C". Some of the questions outlined in the FAQ include the following:

1. What are blue-green algae?
2. What are algal blooms and why do they happen?
3. Are algal blooms poisonous?
4. What happens if blue-green algae is in my drinking water?
5. Who do I call if I suspect the bloom is blue-green algae?
6. What do I do if I see blue-green algae on my shoreline?
7. What other testing for blue-green algae toxins in Lake Erie is being done?

P. Roberts suggests the video be shown to the 400-500 participants to be ferried to Peche Island for Peche Island Day to be held on September 22, 2012.

A. Parent states the second phase of WECEC's education campaign will include energy conservation. This topic will create the potential for many campaign partners, including educational institutions, local distribution companies such as Enwin as well as businesses who sell energy conserving products to homeowners.

A. Parent indicates planning has begun for the 2012 Provincial Environmental Advisory Committee Symposium to be held on November 17, 2012 from 9:00 o'clock a.m. to 3:00 o'clock p.m. at the Pelee Days Inn in Leamington. 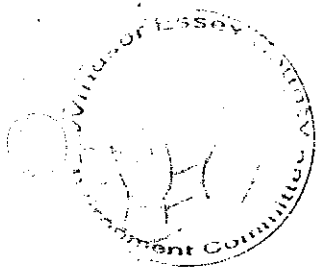
