## **ORDER**

- 1. THIS COURT ORDERS that until the return of the of the Applicant's motion for a stay pursuant to section 273(4) of the *Municipal Act, 2001*, the City of Windsor may not subject persons to penalties for failing to comply with Residential Rental Housing By-Law 14-2023 ("RRH"), but may continue to do the following:
  - (a) encourage voluntary compliance with RRH; and

- (b) advise homeowners of the requirement to apply for a license under RRH.
- 2. For greater clarity, nothing in this Order shall prohibit the City's Fire, Building or By-Law Enforcement officers from enforcing existing statutes and regulatory by-laws, including but not limited to the following statutes and City by-laws:

Building Code Act, 1992; Fire Protection and Prevention Act, 1997; Fence By-law 170-2012; Ice and Snow Removal By-law 8544; Noise By-law 6716; Parking By-law 9023; Property Standards By-law 9-2019; Waste Collection and Disposal By-law 2-2006; Yard Maintenance and Anti-Littering By-law 3-2006; Zoning By-law 8600; Keeping of Animals By-law 8156; Feeding of Wild Animals By-law 67-2021; Business Licensing By-law 395-2004; Short-term Rental By-law 115-2022; Registration, Licensing and Control of Dogs By-law 245-2004; Fireworks By-law 37-2004; Idling of Vehicles and Boats By-law 233-2001; and Vital Services By-law 195-2011.

- 3. THIS COURT ORDERS that the motion for leave to appeal from the Order of Howard J., dated May 16, 2023 is hereby dismissed.
- 4. THIS COURT ORDERS that the costs of this motion for leave to appeal be left to the judge hearing the motion for a stay pursuant to section 273(4) of the *Municipal Act*, 2001.
