## TAX PAYMENT DEFERRAL APPLICATION

Low Income Seniors & Low Income Disabled Persons (Municipal Act, 2001 – Section 319 (c.25)

- The property tax deferral program provides the taxpayer an option to defer year-over-year property tax increases until the subject property is sold or otherwise becomes the property of any person other than the eligible person or their spouse.

  EXAMPLE: 2022 FINAL TAXES \$1,779.61 2023 FINAL TAXES: \$1,862.07 ELIGIBLE DEFERRAL AMOUNT \$82.46
- The <u>deadline</u> for submitting applications is <u>the last day of February of the year following the year for which the application is made</u> (February 29, 2024).
- To be eligible for a tax deferral, you must satisfy the conditions which are outlined under the section of which you are applying.
