## **To His Worship the Mayor and Members of Council:**

This is the Willistead Manor Inc. Annual Report to City Council on the affairs and operations of the Corporation for the calendar year 2016.

The Willistead Manor Inc. Board of Directors act in a policy advisory capacity to City Council on the operation of Willistead Manor Inc.; however, the ongoing management of the facility is under the direction of the Office of the Community Development and Health Commissioner. A full report of the activities in the facility may be obtained from that Service Area.

## **Introduction and Background**

The *City of Windsor Act, 1981* established a Corporation without share capital under the name of Willistead Manor Inc., with the objective to receive, maintain, manage, control and use donations for charitable purposes for the rehabilitation of Willistead Manor Inc. For the purpose of attaining its objective, the Corporation “Willistead Manor Inc.” has the power to accept and hold any real or personal property granted, donated, devised, bequeathed or otherwise conveyed to it and to convert any such property into money and further to advise City Council respecting the following:

1. The operation of Willistead Manor Inc.;
2. The development and maintenance of the grounds of "Willistead Park";
3. The promotion and development of Willistead Manor Inc. as a centre for amusement, entertainment and exhibitions;
4. The promotion of meetings, receptions and displays in Willistead Manor;
5. The promotion of educational or cultural activities in Willistead Manor;
6. The promotion of the performing arts, including musical and artistic work, in Willistead Manor.

Pursuant to Section 12 of By-law Number 1 of the Corporation, enacted October 29, 1981, the Board of Directors shall, once annually, hold a meeting at which will be approved for submission to City Council, a review of the affairs and operations of the Corporation for the year immediately preceding and a financial statement which contains a profit and loss statement and a balance sheet for the year. This report is submitted in accordance with By-law Number 1.

## *Acquisitions Committee*

The Acquisitions Committee had meetings throughout the year to review and research ongoing and future projects.

The committee oversaw the installation of the dining room drapery. The fabric consisted of raisin color damask with a bullion fringe. We have received many compliments on its appearance. We also completed the reupholster of the dining room chairs. The stripe fabric chosen for the chairs blends nicely with the beautiful rug given to Willistead by the Sanborn family. These additions gave the dining room a new and refreshed feeling. That space is often used for wedding ceremonies, and the new elements have garnered much accolade.

Acquisitions, working with city representatives finalized the details for the second floor servery. The work will commence in early 2017, and will not only be functional, but give a great aesthetic for all who will view it.

We are grateful to Bill and Rochelle Tepperman for their generous donation of items. Two pieces of art will be hung in the manor, and the remainder will go in our 2017 sale. Money received from our sale goes to offset funding toward many of our desired projects.

The committee oversaw the placement of the two new carpets in Mrs. Walker's bedroom and dressing room. The bedroom received a trellis patterned area rug that blends wonderfully with the wallpaper. The dressing room received a Persian design wool carpet that gave that space an exciting visual. We have received a number of comments on how the rooms have been transformed to new heights with these additions.

The manor was fortunate to receive a donation of items from the Fox estate. Mr. & Mrs. Fox were the caretakers for the Walker family. Notably, we received original letters from Mary Walker thanking them and giving instructions of her transitioning when she left Walkerville. These letters have given us much insight and will be very important to our historic file. One is currently on display in Mrs. Walker's bedroom. The others will be exhibited in the coach house. Also received from the Fox estate where a settee and two chairs given to them by the Walker's as wedding gifts. We will refurbish them and place them in Mrs. Walker's dressing room. They also donated a number of vintage books with beautiful covers that will be placed on the library shelves. These donations are amazing tangible examples of the Walker family's generosity. The displayed items will give those that view them the sense of a deeper connection to Edward & Mary Walker.

On behalf of the entire board, we are grateful to all that donate to enhance and help preserve this historical gem in our city.

St. Clair College staff and 20 students, 6 professional decorators and 25 Friends spent two days **Decorating the Manor** in full holiday style for Open Houses and 12 outside tours. Our Coach House was once again the scene for eight crafters/artisans and our jumble table even though weather and format changes did not draw the crowds we usually do.

**Willistead Manor – A History and A Guide** - is still presented at all of our events and continues to sell well ... we also sell pewter medallions showing the depiction of the Manor and at Christmas a lot of the public showed interest and bought for selves or presents.

**General Meetings** for the Friends takes place every second Monday evening of the month and it is amazing that we have 30 to 35 out to take part in the planning and executing of the activities we do.

A sincere thank you to all the Friends, families, City Staff and Board members, and to all supporters of our efforts as volunteers at the Manor.

***Manor Club***

*The fiscal year ending December 31, 2016 concluded with Willistead Manor Inc. continuing its “Manor Club” fund raising campaign. Operating on a budget of \$4,500.00 all of which is dedicated to the Manor Club campaign, various fundraising efforts were undertaken to promote the Willistead Manor Club this year and in the future. A positive operating fund balance from 2015 was included in the 2016 budget, which, combined with normal operating expenses, resulted in a cumulative surplus for 2016 of \$36,616.19.*

*Eighteen memberships in the Manor Club were renewed, amounting to \$2,227.55. Five of the Manor Club contributions exceeded the \$100.00 annual membership established by the Board of Directors. Since its inception in 1982, contributions to the Manor Club total \$323,477.19.*

*As the Board is empowered under Section 6 (c) of its governing legislation*

*“to pay over from time to time monies received by the Corporation to the City Treasurer and the City shall use any monies so received only for the purposes of operating, renovating and furnishing Willistead Manor”.*

*We will be presenting a cheque to the City Treasurer in the amount of \$2,258.50 to be applied toward the continued restoration of Willistead.*

***Art-in-the-Park***

*Art-in-the-Park, co-sponsored by the City of Windsor and the Rotary Club of Windsor (1918), contributed \$35,154.00 to the Willistead Restoration Fund for 2016. This joint effort, which commenced in 1978, has generated \$1,271,184.88 towards Willistead Restoration projects.*

***Willistead Classic Car Show***

*The Willistead Classic Car Show event was not held in 2016. This show, which began in 1987, has generated a total of \$209,152.71 toward Willistead restoration projects.*

***Friends of Willistead***

*The Friends of Willistead have generated ‘contributions’ totalling \$110,466.00 since their inception in 1982. They have also volunteered countless hours of labour, particularly decorating for Christmas and assisting in furnishings acquisitions.*

***Furniture and Furnishings***

*Furniture and furnishings valued at approximately \$489,305 have been donated to Willistead over the years by many generous members of the community.*

***Willistead Capital Restoration***

*All of the details listed above indicate another successful year for Willistead and the various activities committed to raising funds for the continued restoration of Willistead. The Willistead Capital Restoration Fund has a balance of \$220,239.16 as at December 31, 2016 year end.*

### ***Willistead Capital Maintenance***

*Since it was established in 2005, the Willistead Capital Maintenance Reserve Fund has funded capital maintenance expenditures totaling \$160,000. The Willistead Capital Maintenance Reserve Fund has a balance of \$17,241.28 as at December 31, 2016 year end.*

### ***Willistead Endowment Fund***

*In 2012, City Council approved the establishment of the Willistead Manor Endowment Fund. The fund is to be used exclusively, and in perpetuity, for the preservation, restoration, and capital improvement of Willistead Manor, and used for any means needed to achieve this purpose. It is intended that the fund be used for infrastructure projects. The minimum capital amount that must be preserved in the fund at all times is set at 50% of the receipted value of life to date contributions to the fund. As at December 31, 2016 the Willistead Endowment Fund has a fund balance of \$16,551.74. The minimum capital balance that must be preserved in the fund as at December 31, 2016 is \$8,188.29.*

### ***Willistead Capital Restoration Project Account***

*In 2012, City Council approved a major capital restoration project at Willistead Manor estimated to cost approximately \$2.2 million with a commitment to provide funding of \$1.5 million (\$150,000 annually over 10 years from 2012-2021) towards this major capital initiative. Additionally, City Council approved Heritage funding of \$75,000 towards this project and the redirection of \$174,707 from previously approved capital projects at Willistead Manor. The remaining funding was to come from the fundraising efforts of the Willistead Manor Inc. Board of Directors. As at December 31, 2016 total donations received to date amount to \$89,550 bringing the total funding available for this project to \$1,089,257. The remaining annual contribution from the City (based on the \$150,000 per year) to be credited to the project for period 2017-2021 is \$750,000. As at December 31, 2016 total expenditures incurred to date on the project account total \$220,094.*

*Additionally, in December 2016 the Federal Economic Development Agency for Southern Ontario approved our application for funding under the Canada 150 Community Infrastructure Program (CIP 150). This approval will provide a non-repayable contribution of up to \$450,000 representing 23% of total eligible project costs provided the work is completed by March 31, 2018.*

*RFP 11-16 for a Heritage Architect Professional was advertised on February 27, 2016. The award of that RFP was granted to Goldsmith Borgal and Company Ltd. by CR398/2016 on June 20, 2016. They will undertake a thorough assessment of the major building envelope components. Construction drawings and specifications will be prepared describing the remediation work required for the deficiencies. The tender for the restoration work will be advertised in 2017 with most of the construction work anticipated in 2017.*
