## 2. BACKGROUND:

Concerns regarding traffic issues on McKay Avenue and Dominion Boulevard have been formally brought forward as follows:

- CR399/2010 directed the City Engineer to proceed with a traffic calming study of McKay Avenue and Dominion Boulevard.
- Under CR100/2012, a petition by McKay Avenue residents requesting traffic calming measures was received by Council, and Administration was directed to proceed with a traffic calming study on McKay Avenue and Dominion Boulevard from Richardie to Norfolk.

This report addresses both CR399/2010 and CR100/2012.

### 3. **DISCUSSION:**

#### **Study Area**

In response to Council direction and the concerns expressed by residents, a traffic calming study was undertaken. In accordance with the City of Windsor Traffic Calming Policy, the study area was expanded in order to allow a "neighbourhood-wide" approach and is bounded by:

- West Grand Boulevard to the north;
- Cabana Road to the south;
- Longfellow Drive on the east;
- McKay Drive on the west.

The study area used for analysis is shown in the attached Public Information Centre panels (Appendix A).

### Overall Approach

The Traffic Calming Policy uses a scoring system to determine the level of traffic calming warranted for a street based on several factors. Streets in the study area are divided into sections between stop controls. Each street section in the study area is scored on each of the following:

- Speed
- Traffic volume
- Collisions
- Presence of cycling facilities
- Presence of pedestrian generators along the street (e.g. schools, parks, religious buildings, community centres, neighbourhood commercial stores/plazas)
- Residential frontage

Speed and volume data was collected within the study area using automatic traffic recorders (tube counts) in September 2011, July 2012, and September 2012.

Collisions in the study area were retrieved from the City collision database. As per the Traffic Calming Policy, a 3-year period of collisions was used for analysis (July 1, 2009 to July 1, 2012). Only collisions that are reducible by traffic calming measures were considered.

### Findings

Based on the scoring system in the Traffic Calming Policy, scores were tabulated for each road section. It should be noted that the scores for each factor and the thresholds for each level of traffic calming are different for collector roads and local roads; the appropriate scoring system was used for each.

As noted in the table above, Level 1 traffic calming was found to be warranted for two road sections in the study area:

- Dominion Boulevard Norfolk to Roselawn
- Norfolk Street McKay to Dominion

Of the points awarded to achieve a Level 1 score on Dominion Boulevard from Norfolk Street to Roselawn Drive, the factor that can be addressed using Level 1 tools was speed. The 85<sup>th</sup> percentile speed (i.e. the speed at or below which 85 percent of the traffic are travelling) for the section from Norfolk to Roselawn was found to be 61 km/h, or 11 km/h higher than the posted speed limit of 50 km/h.

The score for Norfolk Street was based primarily on high traffic volumes. While average daily traffic (ADT) observed on Norfolk Street (6,800 vehicles per day) does exceed the volume threshold for a Class II Collector (6,000 vehicles per day), any traffic calming measures placed on Norfolk Street would tend to encourage an undesirable diversion traffic onto local streets. Therefore, Norfolk Street was not carried forward for traffic calming.

Additionally, based on resident concerns brought forward by the ward councillor, staff were requested to consider the potential for a reversal of the stop sign at McKay Avenue and Richardie Boulevard.

Based on these identified issues, a traffic calming solution was prepared by staff.

### **Proposed Traffic Calming Solution**

The proposed traffic calming solution presented at the PIC is shown in Appendix B (board from PIC). A discussion of how this solution was arrived at is provided below.

As noted above, two issues were identified to be addressed in the traffic calming solution:

- speeds on Dominion Boulevard (Norfolk to Roselawn); and
- based on discussions with the Ward Councillor and the petitioners, a stop sign reversal was proposed at McKay Avenue and Richardie Boulevard.

For Dominion Boulevard, several objectives were identified for potential traffic calming measures:

- it should be appropriate for Level 1 traffic calming (signage only);
- it should be effective at reducing vehicle speeds; and
- it should not encourage traffic diversion onto lower classification streets.

In order to address all of the identified objectives, radar speed signs were selected as the preferred solution, to be placed at locations as shown in Appendix B. Rather than providing a readout of the driver's speed as in other types of radar speed signs, the proposed signs would remain blank for vehicles at or below the posted speed and display "MAXIMUM 50 – SLOW DOWN" for vehicles exceeding the posted speed.

This style of radar speed board has been used with good success in other jurisdictions. A before-and-after study by the City of Calgary of 8 installations found that on average, the number of extreme speeders (i.e. speeders exceeding the speed limit by 16 km/h or more) dropped by half after the installation of the radar speed signs.

The estimated cost to undertake the Dominion Boulevard Radar Speed Signs is \$21,000. (It should be noted that these costs are higher than those presented to the public at the PIC. Since the PIC, it was identified that an additional pole would be required, and therefore an additional \$3,000 including supply and installation of a pole, base, and footing, increasing the overall cost for the radar speed signs from \$18,000 to \$21,000.)

For McKay Avenue, a stop sign reversal was proposed at the intersection with Richardie Boulevard.

This intersection does not meet the warrant for an all-way stop. However, a reversal of the existing two-way stop was possible based on similar traffic cross-volumes. McKay Avenue is proposed to be stop-controlled and Richardie Boulevard would become the through street.

The estimated cost to install the McKay Avenue/Richardie Boulevard Stop Sign Reversal is \$2,000

#### Consultation

The proposed traffic calming solution was communicated to the public at a public information centre (PIC) on October 2, 2012.

- Notices and comment sheets for the PIC were hand delivered to McKay and Dominion residents in the study area on September 25, and
- the PIC was advertised:
  - o in the Windsor Star (in the Saturday, September 29 edition) and
  - o through a media release.

Since the proposed measures on McKay Avenue and on Dominion Boulevard are not dependent on each other, to gauge community support for each measure, support by residents on McKay Avenue was considered for the McKay/Richardie stop sign reversal, and support by residents on Dominion Boulevard was considered for the electronic speed limit signs on Dominion Boulevard.

Comment sheets were collected at the PIC, via mail, email, fax or drop-off.

To gauge support for the proposed traffic calming solution in accordance with the Policy, on October 5, notices were hand delivered to McKay and Dominion residents requesting them to phone 311 with their response to the following four survey questions:

- 1) Do you support traffic calming in the study area identified? Yes or No.
- 2) A stop sign reversal means traffic will be required to stop on McKay instead of Richardie at this intersection. Do you support the proposed stop sign reversal on McKay? Yes or No
- 3) Do you support the installation of electronic speed limit signs on Dominion? Yes or No
- 4) Do you have any further comments?

The survey instructions stated that similar to other projects, non-responses would be considered to be opposition to proceeding with the improvements. A copy of the notice is included in Appendix A.

The results of the survey were as follows:

Based on the responses received, neither the stop sign reversal at McKay Avenue and Richardie Boulevard nor the electronic speed signs on Dominion Boulevard have met the 66% threshold of support given in the City of Windsor Traffic Calming Policy. In accordance with the Policy, Administration does not recommend implementing either proposed solution.

### **Resident Comments Received**

In addition to the specific yes-or-no survey questions summarized above, residents were encouraged to provide comments and feedback at several points in the study process. The specific comments given are provided in Appendix C. The main issues raised are summarized as follows:

Concerns related to existing conditions in the study area

Additionally, a number of residents provided suggestions for various measures to address perceived traffic problems. In general, these suggestions reflected a wide range of perspectives and in some cases were diametrically opposed to each other, ranging from suggestions that would reduce speed or volumes on study area streets (e.g. speed humps or full closures) to ones that would increase speed and/or volume (e.g. removal of parking). Overall, the suggestions received were not conclusive in identifying additional areas of concern.

## \*Identified Issue: Pedestrian Crossing on Dominion Boulevard

As noted in the table, concerns were raised by residents at the PIC and in comments received about difficulty for pedestrians crossing Dominion Boulevard at the point where the sidewalk switches from one side of the road to the other.

Currently, between Norfolk Drive and Cabana Road, sidewalks are provided on only one side of Dominion Boulevard. At the "S" curve approximately 80 metres north of Cabana Road, the sidewalk on Dominion Boulevard switches from the west side to the east side, encouraging pedestrians to cross between the two curves.

To address this issue, it is recommended that the sidewalk on the east side of Dominion Boulevard be extended northerly to Roselawn Drive in order to encourage pedestrians on Dominion Boulevard to cross at an intersection location. Dominion Boulevard is a Class I Collector for which sidewalks are recommended on both sides of the street.

The cost of constructing the sidewalk in this area is approximately \$16,000.

## 5. FINANCIAL MATTERS:

#### **Dominion Boulevard Sidewalk**

The estimated cost to construct a 1.5 metre wide sidewalk, including driveway sawcuts and a curb cut at Roselawn Drive, on the east side of Dominion Boulevard from the existing endpoint north of Cabana Road to Roselawn Drive (total length: 196 m) is \$16,000.

To date Council has approved a total funding of \$1,050,000 under project # 7045034 (Pedestrian Safety Improvement). To date there are sufficient funds in this project to fund these expenses. All the costs will be charged to 007-5410-01490-02942-7045034.

### 7. CONCLUSION:

Due to lack of support from local residents, Administration recommends that the proposed traffic calming solution not be implemented. Windsor Police Services have been notified for action they deem necessary as resources allow.

To improve safety for pedestrians on Dominion Boulevard, it is recommended that the sidewalk on the east side of Dominion Boulevard be extended from its current endpoint north of Cabana Road to Roselawn Drive to encourage pedestrian crossing at an intersection location.

RE: TRAFFIC CALMING STUDY - MCKAY, DOMINION & LONGFELLOW (FROM WEST GRAND TO CABANA)

The City of Windsor held a Public Information Centre (PIC) on Tuesday, October 2, 2012 to present the proposed traffic calming concept for your neighbourhood and to gather public input.

The attached drawing illustrates the two proposed traffic calming measures recommended for your neighbourhood, which will be considered independently. Support must be established from at least 66% of the residents on McKay to move forward with the stop sign reversal at McKay/Richardie, and from at least 66% of the residents on Dominion to move forward with the proposed electronic speed limit signs on Dominion.

To voice your opinion, we ask that you please call 311 and:

- Identify that you are calling about the McKay, Dominion & Longfellow traffic calming study
- Provide your name and address
- Provide your answers to the following prescribed questions:
  - 1) Do you support traffic calming in the study area identified? Yes or No
  - A stop sign reversal means traffic will be required to stop on McKay instead of Richardie at this intersection. Do you support the proposed stop sign reversal on McKay? Yes or No
  - 3) Do you support the installation of electronic speed limit signs on Dominion? Yes or No
  - 4) Do you have any further comments?

The City's 311 Call Centre is open from 7:00 a.m. to 7:00 p.m., Monday to Friday. Similar to other petitioned projects, non-responses must be considered to be opposition to proceeding with these improvements. (Only one vote per household will be considered).


