That the Chief Administrative Officer and City Clerk **BE AUTHORIZED** to execute any agreements, declarations or approvals and any other such documents required resulting from receiving funding from the National Crime Prevention Strategy 2024, satisfactory in form to the City Solicitor, in financial content to the City Treasurer, and in technical content to the Executive Director of Parks, Recreation and Facilities, or designates; and,

That the Executive Director of Parks, Recreation and Facilities or their authorized designate **BE AUTHORIZED**, throughout the duration of the National Crime Prevention Fund program and any subsequent related programs and/or related program extensions to take such actions required to implement, operationalize and manage the program, apply practical operational tasks and activities, approve projects, allocate funds, withdraw, negotiate and re-allocate program funds including the reallocation between different program components to maintain and ensure compliance with program rules and criteria and/or to enable full take up of program funds in accordance with the relevant municipal processes; and further,

That the Chief Administrative Officer **AUTHORIZE** the signing of all claims and applicable reports and other such documents, as required as part of receiving funding from the National Crime Prevention Strategy 2024, to the Executive Director of Parks,
