### 5. Business Items

### 5.1 Public Art Policy Review

Leisha Nazarewich, Acting Chair invites the Members to introduce themselves.

The Presentation entitled "Community Public Art Working Group – City of Windsor" is **attached** as Appendix "A" and Salina Larocque, Cultural Development Coordinator provides an overview of the Committee Mandate, duties and responsibilities, the Public Art Policy, general management of the collection of works of art, acceptance of gifts, donations and bequests and deaccessioning of artwork.

### The Mandate of the Community Public Art Working Group is as follows:

- Review all proposed public art projects, through established procedures and guidelines, on a project-by-project basis, in partnership with City administration.
- Review implementation and maintenance of public art inventory, and implementation of the accessioning and de-accessioning of components of the Public Art Policy, in partnership with City administration.
- Review proposed artwork gifts, bequests and donations to the City of Windsor according to established guidelines, and provide input and recommendations to City administration.
- Ensure that proper maintenance program of public artworks is in place and practiced, in collaboration with City administration.
- Liaise with the Cultural Development Coordinator to encourage the development of private sector public art and public-private partnerships for public art, and as needed assist with community consultations facilitated by municipal staff.

### Community Public Art Working Group Meeting Minutes

Leisha Nazarewich, Acting Chair asks if groups or individuals have projects to bring forward, will they be invited to present before the Working Group. Michelle Staadegaard responds that Salina Laroque will have spoken with the artist or the organization about the project to ensure that all of the information is available. She will also determine if any consultations are required prior to meeting with Parks or Planning and to make sure that the project is feasible.

Terrence Travis inquires as a working artist if he is restricted from submitting an application and if not, is there a best practice. Michelle Staadegaard responds if he will benefitting from this, he will have to declare a conflict of interest. Salina Larocque advises that this matter will be reviewed and will report back.

In response to a question asked by Terrence Travis regarding if the city keeps an inventory of public art as asset and is there a history of any of those assets being traded or liquidated, Michelle Staadegaard responds that some items have been deaccessioned due to their condition and adds that items that have hit their legal agreement (only meant to be temporary) will be coming to the Working Group.

Ashley Kijewski asks if funding for public art proposals is provided by the city. Michelle Staadegaard responds that most of the projects are coming in from an organization and is self-funded. Secured funding is one of the requirements for proposed public art projects. The Working Group will consider projects based on merit and may approve a project proposal that is not fully funded so the applicant may move forward with securing funding. Christopher Menard adds that eligible applicants may apply for funding through the Arts, Culture and Heritage Fund through the City of Windsor.

Leisha Nazarewich, Acting Chair remarks that the information provided by Administration is the basic understanding of the role of the Working Group in terms of when the projects come forward.

Michelle Staadegaard advises that Administration will be reviewing the Public Art Policy this year and will be provided to the Working Group for comment.

### 5.2 Plaques, Monument and Memorials Policy Review

Michelle Staadegaard indicates that Administration will also be reviewing the Plaques, Monument and Memorials Policy which will be forwarded to the Working Group for comment and recommendation.

### 5.3 Museum Sub-Committee Review

Madelyn Della Valle, Museum Curator states that the Museum is run by the City of Windsor, and Council is the decision-maker. In order to acquire their yearly Community Museum Operating Grant, there are a series of rules and their governance Policy says

that there needs to be a Museum Sub-Committee which is formed through a member of Windsor Historic Sites (which owns the Francois Baby House). Museum Windsor is formed through the Francois Baby House, the Chimczuk Museum and the Duff Baby House. The Museum Sub-Committee is comprised of a member from the Windsor Historic Sites, a member of their museum volunteer group and three members from the Community Public Art Working Group. Four meetings per year are required as per the rules of the Community Museum Operating Grant and changes in policy, activities, statistics will be brought forward to the Community Public Art Working Group. There is also a Museum Capital Reserve Fund, also known as the Facility Committee which is a fund for the Francois Baby House, the minutes of which will be provided to the Working Group.

Christopher Menards suggests that the Museum Sub-Committees meetings be combined with the Community Public Art Working Group, i.e. the Sub-Committee will meet a half hour before the Working Group. Madelyn Della Valle reiterates that the Museum Sub-Committee must meet four times a year. The Acting Chair indicates that the Working Group will meet only when there is a public art project to review.

Michelle Staadegaard adds that the Mandate prescribes that the Working Group meet on a quarterly basis.

### Ambassador Bridge With Geese in the Fog

As a photographer, I have often imagined images that one could capture. Images that are only thoughts until realized ... images that mean something artistically personal to me. I hope to evoke an emotion, a thought or a distant memory to the viewer. The Ambassador Bridge image is one I have had in the back of my mind for many years - a foggy day with the grandness of a steel bridge rising up and disappearing into the fog. I imagined that there would be a mystery to what lay beyond.

So many people have told me why they love this image and every interpretation is different. Some have felt a profound calming; some have expressed the mystery of the unknown beyond the fog and compared it to life; and some thought of the future of our soul as we pass from one state of existence to our ultimate eventuality.

This image seems to have touched many people, not just locally but internationally. People that have moved away from their home town have requested prints to have a little piece of Windsor to remind them of their roots in the city. Everyone has a different reason for why it means so much to them. Many had grandparents that helped to build the bridge. Some commuted over the bridge daily to work in Detroit.

I feel it is necessary to preserve this image in the Windsor archive for many reasons. One Windsor official summed it up far better than I could by saying: "Given the artistic merit and aesthetic appeal of this work; the themes of river, land, trade, nature and industry, heritage, and International relations; and the source of inspiration that a contemporary, practicing artist who is living, working, and thriving in the community can be, I believe this work absolutely aligns with the mandate, priorities, and responsibilities of the City of Windsor's Public Art Policy."

I am humbled by all the attention and love this image has received. I am overwhelmed by the joy people have found in it and all the different meaningful interpretations and emotional responses it has generated. It is all a photographer could dream of his work evoking.



# Our Iconic Ambassador Bridge

The Ambassador Bridge, our beautiful old bridge, has served our business community well.

She will continue to do so, even if only in the shadow of the "new kid in town" — the Gordie Howe International Bridge.

I, for one, will always view her as the grand matriarch of our waterfront, the one deserving respect and fondness.

We all may have become a little complacent in her true glory. She is stunning and ever changing in appearance through all types of weather, as illustrated in the accompanying image on this page.

The Ambassador Bridge has been an iconic landmark since opening in November 1929. Many people have told me with great pride that their grandfathers helped build the bridge.


The 1.5 mile long bridge has truly been an

ambassador between Canada and the United States. She has contributed immensely to both the Windsor and Detroit business communities and has been a lifeline of commercial exchange between the two cities and beyond.

The bridge carries roughly 25% of the goods exchanged between the two countries every day. It is the busiest international crossing in North America with more than 40,000 commuters, tourists and truck drivers carrying between three to four hundred million dollars' worth of goods cross the Windsor-Detroit border EACH DAY.

It has provided a vital link to the Windsor economy.

We do honour her long, past service, as the new Gordie Howe International Bridge will soon help to keep up with the increasing demands and take us into the future.

Stan Beatty, a long-time professional photographer in Windsor, captured the iconic structure on a foggy morning in January of 2023.


Beatty was motivated to capture a certain mood and feel given the setting and chose to render the image in black and white to enhance the desired effect.

To add to the composition, the birds in the lower foreground and the seemingly disappearing bridge in the mist, the photo has garnered a lot of fans and customer's Beatty's fine art photos.

For Beatty, the image speaks to larger themes than just a fog and a bridge.

"We're always traveling forward with all the plans that we make in life, we don't really know what's at the end of that bridge," said Beatty. "And, that kind of gives it that mystery - with the fog being shrouded in it because you can't even see Detroit in the picture, as is the same in our future, we can plan all we like but in reality, anything can happen, that is the "fog" of all our futures as we cross that bridge."

### **Project proposal:**

Sandwich West, presently undergoing enhancements facilitated by the new Gordie Howe International Bridge, presents a unique prospect for the Francophone community. Serving as the primary representative, the Association des communautés francophones de l'Ontario Windsor Essex Chatham-Kent (ACFO WECK) can contribute substantially to the community's development. The project involves rebuilding the Francophone community tri-centenary canoe monument. In line with the theme of the explorer, Antoine Laumet de Lamothe Cadillac, this initiative seeks to inform the diverse Sandwich West community about the rich French Canadian heritage of our region.



The primary goals of this project revolves around enhancing public spaces, fostering community engagement, and organizing cultural celebrations. Leveraging the upgraded park facilities, the project seeks to strengthen social connections, deepen the understanding of Sandwich West's history, and instill a sense of belonging within the Francophone and Francophile community. Key deliverables include the construction of the tri-centenary canoe monument, a commemorative plaque, a promotional campaign for awareness, and a community event unveiling the new site.

A strategic partnership with Gordie Howe International Bridge has provided us funding for this project. This funding will help us cover the cost of fabrication, installation, and maintenance of the tricentenary canoe monument. Along with active participation from various Francophone organizations, such as the Centre Communautaire Francophone Windsor Essex Kent, Workforce Windsor Essex, Conseil Scolaire Catholique Providence, Conseil Scolaire Viamonde, Windsor-Essex Bilingual Legal Clinic, Réseau Immigration Francophone Centre Sud-Ouest, French Avenir North America, Résidence Richelieu as well as the City of Windsor to ensure an ongoing comprehensive and inclusive approach to this project. Collaborating with Custom Metal Fabricating, known for their expertise in producing durable public art installations in the Windsor region as well as their work projects for the City of Windsor, further enhances the project's credibility and impact.

The project extends its impact beyond the monument's completion by establishing an enduring legacy through annual events. For example, scheduled for September 25th, 2024 — Franco-Ontarien Raising of the Flag Day — the public celebration will include the unveiling of the new commemorative site. These activities aim to engage the community, highlight achievements, and celebrate the rich French Canadian heritage of Sandwich Town. Additionally, by utilizing modern technology, a QR code on the commemorative plaque will provide access to additional resources, displaying a counter and necessary data on a dedicated landing page. Collaboration with school boards, tourism bureaus, and stronger French partnerships within the community will further boost tourism and enhance awareness of Sandwich Town and its tricentenary monument. Furthermore, all residents and visitors will benefit from its physical improvements, beautification, and cultural additions.


The ACFO WECK project in Sandwich West, supported by funding from the Gordie Howe International Bridge and collaborations with various Francophone organizations, aims to reconstruct the tri-centenary canoe monument. This initiative not only celebrates French Canadian heritage but also enhances public spaces, fosters community engagement, and organizes cultural celebrations. This reflects a commitment to community involvement and the enduring legacy of the project, contributing to a more enriched and inclusive cultural landscape in Sandwich West.







# Public Art Projects / Proposals for consideration

1] Ambassador Bridge in the Fog.

- Type: Donation.
- Location: Proposed for acceptance into the City's Public Art Collection.
- Details:
  - Photograph, black and white.
  - Depicts Ambassador Bridge with geese flying into the fog.
  - Donated by local photographer.
  - Artist bio, statement, and details in supporting materials.

2] ACFO-WECK Francophone Canoe.

- Type: Donation.
- Location: Proposed for Sandwich Town.
- Details:
  - Redesigned Francophone monument.
  - Composed of a canoe installed vertically into a concrete base.
  - Includes signage and flags.
  - ACFO-WECK details, statement, project proposal, and images in supporting materials.

3] Wampum Peace Belt.

- Type: Deaccession.
- Location: Currently in Mill Park in Sandwich Town.
- Details:
  - War of 1812 Wampum Peace Belt temporary public art installation.
  - Best described as industrial, ecological weaving of 2,988 plastic water bottles, filled with expandable construction foam for strength, refashioned as wampum beads, and used to create a large free-standing sculptural replica of the Peace Wampum Belt of 1812 – a 200 year-old symbol of peace and friendship between First Nations and the British crown.
  - The War of 1812 Peace Wampum Belt is the creation of Lorraine Steele visual artist whose work includes collaboration with interior designers to produce large-scale mural work for private and commercial spaces, private commissioned landscape and portrait work, and set design and painting for several local community theatre groups; and Phil McLeod designer with Partners Design for 25 years, with over 35 years experience in creative marketing, illustration, and design.
  - Funded originally as part of the City of Windsor's War of 1812 Legacy Project in 2013, with funding from the Government of Canada Department

of Canadian Heritage, as part of the 1812 commemoration activities that included *The Capture of Detroit* family-fun festival held August 25, 2012.

- This work was estimated to have a ten-year lifespan and planned for public exhibition up to a maximum of ten years.
- The artwork is currently in disrepair, with degradation of structure and materials, and has passed its estimated exhibition lifespan.
- The community has shown interest in having this work removed.
- Removal falls within the scope of agreement surrounding the project.
- Wampum Belt images are included in supporting materials.

### 4] Ford City Murals.

- Type: Relocation.
- Location: Proposed to remain within Ford City, if possible.
- Details:
  - 2 Ford City murals are in need of relocation.
  - Shift Change 36 feet long x 11 feet tall. Image of workers coming/going.
  - Welcome to Ford City Letters are 17 feet long and can be spaced to flex vertical height, with a minimum clearance of 16 feet. Image of man sitting astride car is 30 feet long x 15 feet tall.
  - New building owners and renovation projects led to removal.
  - Public Survey was opened to gather information and desires from the community, including offers to host the artworks, on where the public would like to see the works re-installed.
  - Survey results have not identified a viable option for relocation within Ford City, as of yet.
  - City staff are currently engaged in finding viable locations for these works and are working with Ford City BIA to identify and explore all potential options.
