1. Call to Order

The Chair calls the meeting to order at 3:32 o'clock p.m. and the Committee considers the Agenda being Schedule A, attached hereto, matters which are dealt with as follows:

2. Declaration of Conflict

None disclosed.

3. Business Items

3.1 Update regarding Arlington, Texas and the request for a Twin City Agreement

The Chair advises that a virtual meeting was held on November 22, 2024, with Sheri Capehart, Program Director, Arlington Sister Cities, City of Arlington, himself, and Sandra Gebauer to discuss a potential partnership with Arlington, Texas.

The remarks as provided by Councillor Angelo Marignani, Chair are as follows:

- Windsor frequently receives partnership requests
- The IRC is interested in pursuing a relationship with Arlington.
- The **Friendship City Policy** was developed to allow for municipal driven partnerships and to manage precedents.
- The 5-year review period falls in line with the Draft Memorandum of Understanding (MOU) provided by Arlington.

Sheri Capehart, Arlington, Texas brought forward the following comments including options for a Windsor-Arlington relationship:

- Arlington is eager for a Sister city partnership in Canada and the City of Windsor as a border city was their first choice.
- A partnership should be a full twin/sister city partnership as per Sister Cities International (SSI).
- Sister City benefits include direct affiliation with SSI's global directory but no fee requirement for Windsor.

Sister City Partnership:

- Formal and long-term (typically 5+ years).
- o Requires alignment with SSI membership and program.

• Alternative- Letter of Interest:

- Start with a mutual Letter of Interest to establish initial steps.
- Delegation visits to Arlington/Windsor could:
- Demonstrate commitment and build rapport.
- o Identify potential community or economic connections.
- o A shorter-term agreement (e.g., 1-2 years) could be proposed as a pilot

Exploration without formal Label:

- Initiate actions informally:
- Exchange city staff for short periods to foster operational understanding.
- Collaborate on mutual interests (tourism, economic development, cultural ties.

The Chair reports that the process will begin with a Letter of Interest from both parties which will demonstrate the City of Windsor's commitment to Arlington. He adds that the Letter of Interest will seek to identify potential community or economic connections that are outside of the municipal spectrum. Once the Letter of Interest has been received by both, delegation visits to Windsor and Arlington will be arranged. Sandra Gebauer advises that the possible next steps would be draft a Letter of Interest, outline the shared goals, and to position the letter as a flexible, exploratory agreement on a trial basis. Ultimately, Arlington, Texas is interested in being a Sister City.

Councillor Ed Sleiman questions if there is any financial commitment to this process. Sandra Gebauer responds that any financial costs would be derived from the visit by the Arlington delegation which would include accommodations, and meals. She adds that the cost of flights would be paid for outgoing delegations.

Councillor Ed Sleiman expresses concern that there may be an influx of cities that wish to be sister cities with the City of Windsor. Sandra Gebauer responds that many requests are received, and notes that the requests are vetted through the IRC.

Ronnie Haidar asks if Arlington is expecting a decision within the next few months. The Chair responds that Arlington expects this relationship to happen within the next year. Ronnie Haidar advises that this is a learning process for the IRC in terms of how we engage with new sister cities by beginning with the friendship city relationship.

Saiful Bhuiyan supports moving forward with this initiative with Arlington, Texas.

Jerry Barycki refers to the opening of the Gordie Howe Bridge and the Chair advises that the City of Windsor has the number one gross domestic product exchange border link in North America.

Sandra Gebauer adds that Sherri Capehart suggested a city staff exchange, i.e. if we are interested in sending city staff (economic development) to Arlington for a short period of time to foster operational understanding.

Moved by Councillor Renaldo Agostino, seconded by Councillor Ed Sleiman, That City of Windsor Administration **BE REQUESTED** to prepare a Letter of Interest to be sent to Arlington, Texas to begin the process of exploring a Friendship City/Sister City relationship.

E-mail to L.T. Zhao from Changchun, China – Inquiry about opportunities with the Windsor Chamber of Commerce

Sandra Gebauer advises in 2022, the IRC was approached by the former Chair of the Chamber of Commerce who asked if an introduction could be arranged between our Chamber of Commerce and our Twin Cities. A letter was drafted and sent to the Twin Cities to determine if there was interest in collaborating and becoming "pseudo" members. She adds that Mannheim, Germany responded to the Chamber of Commerce. She suggests reaching out to the Acting Chair of the Windsor Chamber of Commerce to establish if there is an interest in this initiative.

Moved by Councillor Renaldo Agostino, seconded by Saiful Bhuiyan,

That the initiative in 2022 of the Chamber of Commerce to reach out to the Twin Cities of the City of Windsor to determine if there is interest in collaborating with the Chamber of Commerce **BE RESENT** to the Acting Chair of the WindsorEssex Chamber of Commerce for a response.

Changchun, the capital city of Jilin Province, is located at the geographical center of Northeast China. With an area of 24,700 square kilometers and a permanent resident population of 9.08 million, it is renowned as the Automobile City, Film City, Science and Education City, and Forest City. The city boasts four distinct seasons and picturesque scenery, with four national 5A-level tourist attractions.

Introduction/Preface

The International Relations Committee continues to promote Windsor's international interests and image through its focus on strengthening the current community based twin city relationships both abroad and in the local community. This is achieved through the committee's continued support towards educational, cultural, social and economic based exchanges. The committee also devotes its energies towards the exploration of potential new or emerging twin city relationships where there is a desire to twin based on a strong local community commitment, and where long term, valuable exchanges are realized.

Mandate

To support the efforts of the Mayor and Council in the enhancement of Windsor's international image.

To promote and enhance our relationship with Twin Cities.

To support international educational and cultural initiatives.

Composition/Membership

The International Relations Committee for the 2014-2018 term consists of 4 City Councillors and 9 members.

Duties and Responsibilities

The duties and responsibilities of the committee are:

- Assist the Mayor and Council in hosting international visitors.
- Co-ordinate agendas and itineraries for trade, culture, education, and government exchanges.
- Consistently reflect the priorities and goals of the Mayor and Council.
- Search out opportunities to tie into provincial and federal efforts.
- Assist the Mayor with international communications and protocol.
- Maintain a network of community representatives from within business, labour, education, arts, services clubs, and multicultural groups.
- Communicate the goals and objectives of the Committee.

- Liaison with Community groups interested in the furtherance of our Twin City relationships.
- Encourage the establishment of cultural and educational ties between interested parties in our respective communities, especially involving children.
- Encourage local business interests to take advantage of our established network of Twin City relationships when considering international business ventures.
- Encourage Trade Missions and exchanges involving our Twin Cities.
- Ensure that visiting dignitaries and representatives of our Twin Cities are properly accommodated and introduced to the appropriate officials and business or community leaders.

Appointment and Term

The Striking Committee of Council appoints members for a period of 4 years.

Agenda and Minutes

In accordance with the City of Windsor's Procedure By-law 98-2011, the Committee Chair will review, identify and prepare agenda items and priorities prior to each meeting. Though the Committee Chair is responsible for conducting meetings and providing direction, they are to ensure a fair and open discussion of agenda items, enabling members to suggest items for the agenda.

Minutes shall be taken of all Committee meetings by a designate of the City Clerk who shall subsequently distribute them as soon as possible to all Committee members.

All matters related to recording and distributing the minutes shall comply with the City of Windsor Policies governing the recording and distribution of the minutes of a Committee of City Council.

Rules of Order

Elections and meetings will be conducted in accordance with Bourinot's Rules of Order and the City of Windsor's Procedural By-Law 98-2011.

Reporting Structure

The International Relations Committee will report to the Planning & Economic Development Standing Committee.

Remuneration

Advisory Committee members receive no compensation for their service on the City's Advisory Committees.

Quorum

Quorum for the International Relations Committee is seven members.

1. POLICY

1.1. A policy outlining the criteria necessary for entering into international friendship and twin city relationships with the City of Windsor.

2. PURPOSE

2.1. This Policy outlines the necessary steps and processes associated in the creation or establishment of entering into a new friendship and/or twin city agreement with another international municipality.

3. SCOPE

3.1. This policy will apply to all proposed friendship and twin city requests made from within the Windsor community or received by the Mayor of the City of Windsor from any international city, municipality or district.

4. **DEFINITIONS**

- **4.1.** *Twin City* refers to a form of legal agreement between two geographically and politically distinct localities for the purpose of promoting cultural and commercial tie. For the purposes of this policy, Twin Cities are defined by a formal request brought to and approved by Council upon recommendation of the International Relations Committee.
- 4.2. Friendship City refers to a less formal agreement between localities. For the purposes of his report, Friendship Cities are characterized by the signing of a Memorandum of Understanding between Mayor's Offices. It is to be used as a first stage in the 'Twinning' relationship and if successful may lead to a formal Twin-City Agreement

5. **RESPONSIBILITY**

5.1. City Council will be responsible for:

- 5.1.1. Reviewing and approving new twin city agreements or partnerships as well as Friendship City MOU agreements.
- **5.2.** The Mayor's Office will be responsible for:
 - 5.2.1. Communicating City Council's resolution regarding a proposed new twin city relationship.
 - 5.2.2. Reviewing recommendations from the International Relations Committee regarding Friendship City requests and approving, if desired, the relationship through a Memorandum of Agreement.
- **5.3.** The Office of the City Clerk will be responsible for:
 - 5.3.1. The collection and cataloguing of official records, letters, agreements or charters when entering into a Friendship City or Twinning Agreement with the City of Windsor, including future correspondence between cities.
- **5.4.** The International Relations Committee (IRC) will be responsible for:
 - 5.4.1. Exploring and investigating new friendship and twin city relationships.
 - 5.4.2. Submitting a recommendation to the Mayor and Council regarding proposed friendship or twinning requests after a formal request has passed through the Mayor's Office and/or a formal investigation has been completed by the committee. Recommendations to City Council will follow normal protocols in the governance model process.
 - 5.4.3. Reviewing this policy and any associated procedures and forms every five years.

6. GOVERNING RULES AND REGULATIONS

- **6.1.** Request for Friendship City Relationships should be community driven, or driven by local municipal governments, supported by a formal organized cultural/ethnic association and must demonstrate that a sustainable relationship can be maintained.
 - 6.1.1. Legitimate and active organizational structure should exist in the related ethnic community to support friendship- based activities (i.e. hosting visiting delegations, providing translation services, conducting meetings/tours/receptions with their business community).
 - 6.1.2. The proposed friendship city should demonstrate certain identifiable similarities or mutual interests with potential for reciprocal cultural, educational and economic benefits.
 - 6.1.3. Friendship City relationships should be maintained for a minimum 5-year term, with the option to extend for an additional 5-year term. Extensions will be made in 5-year increments and will include an MOU.
 - 6.1.4. Friendship City relationships should be evaluated at the end of each defined term to determine is the relationship has seen any benefit and/or measurable results that the City of Windsor and the partner organization expect as a result of the Partnership.
 - 6.1.5. If Friendship City partnerships receive a successful evaluation, the option to formalize the relationship into a twinning relationship may be exercised as per section 6.2 of this policy

- **6.2.** Request for twinning's should also be community driven, supported by a formal organized cultural/ethnic association and must demonstrate that a sustainable relationship can be maintained.
 - 6.2.1. As with Friendship Cities, legitimate and active organizational structure should exist in the related ethnic community to support twinning activities and The proposed twin city should demonstrate certain identifiable similarities or mutual interests with potential for reciprocal cultural, educational and economic benefits.
 - 6.2.2. Details of a twinning proposal must be submitted in writing to the Mayor of Windsor, outlining a long-term plan and the community's responsibility for sustaining ongoing activities.
 - 6.2.3. If recommended by the IRC and approved by Council, a formal letter of interest is to be forwarded to the Mayor of the proposed twin city.
 - 6.2.4. If the proposed twin city approves Windsor's proposal, a formal signing protocol will be arranged.
 - 6.2.5. The twinning charter can be dissolved upon the mutual agreement between the twin cities.
 - 6.2.6. If a twinning request is received from another city outside of the friendship city realm, the request will be reviewed by the IRC and one or more of the following actions may occur;
 - 6.2.6.1. Investigate and forward a recommendation to the Mayor's Office for decision on Twinning Agreement.
 - 6.2.6.2. Review the request and offer a recommendation to the Friendship City program.

7. RECORDS, FORMS AND ATTACHMENTS

7.1. Records are the responsibility of The Office of the City Clerk and will be kept in accordance with the Records Retention Bylaw #21-2013 as amended from time to time.

First Glowing Bike Path in Poland Opened!

Near the town of Lidzbark Warmiński, the first bike path in our country that glows at night has been opened—it is illuminated by so-called luminophores, a synthetic material powered by solar energy.

The inspiration for TPA Technical Research Institute Sp. z o.o., the company that designed it, was the *Starry Night* bike path by Studio Roosegaarde. You might have read about the solar-powered bike path in our article from 2014.

According to Igor Ruttmar, the president of TPA Sp. z o.o., the material from which the path is made can emit light continuously for 10 hours. Each day, the material accumulates energy, allowing it to glow at night. Waldemar Królikowski, the director of the General Directorate for National Roads and Highways, states that this type of bike path was built to enhance road safety. According to Next Nature Network, luminophores, or as some call them "material particles," can emit light in various colors. However, the designers chose blue, as they believed it blends best with the surroundings. The ratio of quality to price and the durability of the materials used were thoroughly examined.



Although the Starry Night bike path provided inspiration, the technology used in producing the Polish bike path differs slightly. Studio Roosegaarde used LED lamps, solar panels, and "light-accumulating paint." The bike path designed by TPA Sp. z o.o. does not require any alternative power sources. The path is still being tested to gather information about its wear and durability.
