I/we will not use the Property for more thanseparate dwelling units, unless I/we first obtain a building permit for additional dwelling unit(s), receive all required approvals from the City of Windsor, and comply with any other "applicable laws" as defined in the Ontario <i>Building Code Act</i> and the <i>Ontario Building Code</i> .

I/we understand that if I/we or any of my/our tenants, agents, employees, or authorized users of the Property use the Property for more than separate dwelling unit(s), I/we may be subject to penalties under various municipal and provincial laws, including without limitation, the Fire Protection and Prevention Act, the Building Code Act, the Planning Act, the City's Zoning By-law, and/or the City's Property Standards By-law			
4.	I/we will inform any and all prospective purchasers, purchasers, and/or tenants of the Property that the Property is approved for a maximum of dwelling unit(s).
