The purpose of this meeting is to give the public an opportunity to comment, and for the Development & Heritage Standing Committee (DHSC) to make recommendation to Council, on the proposed amendments. This matter may be removed from the agenda after this notice is mailed.

The meeting is open to any person. You will have an opportunity to speak on the proposed amendments. Written or oral comments are acceptable. Any personal information may become part of the public record.

No person or public body shall be added as a party to the hearing of the appeal unless, before the by-law was passed, the person or public body made oral submissions at the public meeting or written submissions to the Council or, in the opinion of the Tribunal, there are reasonable grounds to add the person or public body as a party.

Take notice that an appeal to the Ontario Land Tribunal in respect to all or part of this ZONING BY-LAW 8600 may be made by filing a notice of appeal with the City Clerk either via the Ontario Land Tribunal e-file service (first-time users will need to register for a My Ontario Account) at <https://olt.gov.on.ca/e-file-service/> by selecting **Windsor (City): Clerk** as the Approval Authority or by mail to **Council Services, City of Windsor, 350 City Hall Square West, Suite 530, Windsor, Ontario N9A 6S1**, no later than 4:30 p.m. at a future date. The filing of an appeal after 4:30 p.m., in person or electronically, will be deemed to have been received the next business day. The appeal fee of \$1,100 can be paid online through e-file or by certified cheque/money order to the Minister of Finance, Province of Ontario. If you wish to appeal to the Ontario Land Tribunal (OLT) or request a fee reduction for an appeal, forms are available from the OLT website at [www.olt.gov.on.ca](http://www.olt.gov.on.ca). If the e-file portal is down, you can submit your appeal to [clerks@citywindsor.ca](mailto:clerks@citywindsor.ca).

If you wish to be notified of the decision of the City of Windsor in respect to the proposed amendment you must make a written request to: **Council Services, City of Windsor, 350 City Hall Square West, Suite 530, Windsor, Ontario N9A 6S1**. Only those persons and/or public body that have made a written request to be notified of the decision shall be mailed a 'Notice of Passing' of the zoning by-law, if passed.

**APPLICANT/COMPANY: 1740945 Ontario Corp.**

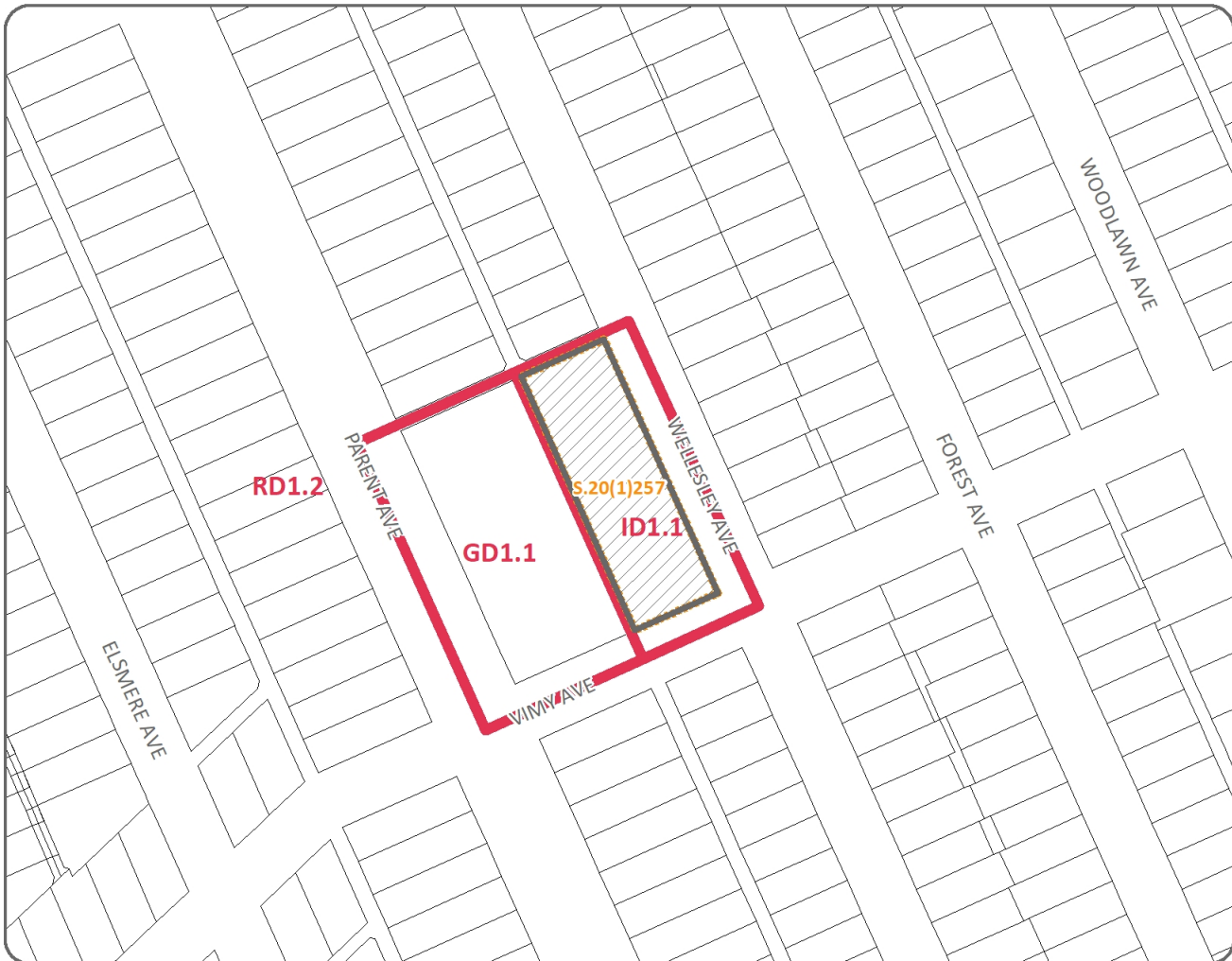
**LOCATION/PROPERTY: 2275 Wellesley Ave.**

The applicant is requesting an amendment to Zoning By-law 8600 to change the zoning for the lands located on the northwest corner of Vimy Avenue and Wellesley Avenue, known municipally as 2275 Wellesley Avenue (the subject property), from Institutional District 1.1 (ID1.1) Site Specific Provision 20(1)257, to a Site Specific Residential District 2.3 (RD2.3) zone to allow interior and exterior alterations to a vacant institutional building [formerly Saint Charles Separate School (1960-1980)] for the purpose of establishing an eight (8) unit Townhome Dwelling on the subject property.

The subject property is located within the South Walkerville Planning District on *Schedule A - Planning Districts & Policy Areas* and a Residential land use designation on *Schedule D - Land Use Plan* to the City of Windsor Official Plan.
